Summary: Luis Guzman was a flutist who joined the Quantico Marine Band in 1921, then joined the U.S. Marine Band in 1923 and served until 1951. In addition to performing, Guzman was a composer and arranger. This collection consists of notated music, photographs, a concert program,

an article, and a booklet about Guzman's compositional career.

Biographical Note

Luis Guzman was born in Colombia, South America, on August 19, 1901. He immigrated to the United States in 1920 and enlisted in the Marine Corps in 1921 as a Private in the Quantico Marine Band in Virginia. He joined the U.S. Marine Band as a flute player in 1923 under Captain William H. Santelmann. In addition to his performing career, Guzman was also a composer and arranger. He was best known for his work *Stephen Foster Melodies*, an arrangement of several tunes by the American songwriter Stephen Collins Foster. Guzman arranged this medley for a variety of musical ensembles, including orchestra and band and a four-part vocal version included in this collection. The composition's dedication reads, "To Mr. Josiah Kirby Lilly of Indianapolis, whose generosity and love for Foster's songs made possible the presentation of this medley." Guzman retired from the Marine Band as a Master Sergeant in 1951. He passed away on February 10, 1974, in Orange, Florida, and his body was laid to rest at Arlington National Cemetery in Virginia.

Scope and Content Note

The Luis Guzman papers document the musical career of flutist and composer/arranger Luis Guzman. The collection contains both materials from Guzman's civilian musical career, such as a copy of his arrangement of the Stephen Foster Melodies, an article reviewing the work's première,

and a program from a solo flute recital he performed, as well as photographs from his time in the Marine Band. The photographs are specifically from two special trips taken by the band outside of Washington, D.C. In addition, the collection contains a booklet from a plant nursery advertising a specific type of orchid named after composer Stephen Foster, whose songs Guzman used in his well-known arrangement.
